**COPYRIGHT AND REPRODUCTION POLICY**

These Collections, which are held within the Oxford Centre for Methodism and Church History, Oxford Brookes University were created by Keith Guyler (1937-2010) and Bill Smith (1932-2018); copyright in the original images subsists in their respective Estates.

Digital images from these collections have been produced by the Oxford Centre for Methodism and Church History, Oxford Brookes University; copyright in those images lies with the university.

**Low resolution images** can be downloaded free of charge from the 'British Methodist Buildings' website for personal use, including powerpoint presentations, so long as these are not for financial or other gain. This use should be acknowledged with the following specified text:

*[Image/title] from 'British Methodist Buildings' online, courtesy Oxford Brookes University and the estates of Keith Guyler and Bill Smith.*

**High resolution images** can be made available by the Oxford Centre for Methodism and Church History, Oxford Brookes University (address below), in which case **the following conditions apply**. These conditions apply to printed or electronic form, including websites. The university reserves the right to refuse permission for reproduction.

- Agreement to these conditions through the completion and return of the attached form is essential.
- Agreement is for use of a specific image[s] in a single publication and not to be construed as repeatable.
- The following specified text for acknowledgement is used:  
*[Image/title] from 'British Methodist Buildings' online, courtesy Oxford Brookes University and the estates of Keith Guyler and Bill Smith.*
- A work should usually appear in its entirety, without more than 10% cropping or overprinted by other text or images. Works in colour must be reproduced in colour. If a detail from a work is sought then specific permission must be obtained from the Oxford Centre for Methodism and Church History, Oxford Brookes University and attributed as a detail from that particular work.
- The Oxford Centre for Methodism and Church History, Oxford Brookes University requires a proof copy before final consent for reproduction is given.
- Only the image supplied (usually electronically) is to be used, and is to be deleted from all electronic retrieval systems after use.
- A copy of the publication shall be supplied to the Oxford Centre for Methodism and Church History, Oxford Brookes University for their records.
- The fee is payable in GB pounds sterling; cheques made payable to '**Oxford Brookes University**'. Invoices can be sent on request.

### Guidance / best practice in reproducing images

Any image, including a photograph, is the original work of the creator. It is a privilege and duty of care to ensure that any reproductions are of the highest quality, and that thought is given to the appropriateness of the image in the chosen context.

Please respect the integrity of an image. Its colours, size, medium and details are all part of the creator's intention and can sometimes get lost in translation when reproduced. Trimming alters the composition and thus the reading of an image. It is important to indicate if you have cropped (maximum 10%); anything less is misrepresentation.
